

PERTAINING TO THE ADOPTION OF REGULATIONS AND SETTING FEES AND CHARGES FOR MOBILE FOOD SERVICE RECIPROCITY LICENSE

WHEREAS, the Board of County Commissioners of Calvert County, Maryland, is *ex officio* the Board of Health for Calvert County, pursuant to Section 3-201, *Health-General Article, Maryland Annotated Code*;

WHEREAS, pursuant to Section 3-202(c) of the *Health-General Article, Maryland Annotated Code*, the Board of County Commissioners of Calvert County, sitting as the Board of Health for Calvert County, has authority to set certain fees and certain charges;

WHEREAS, by 2017 *Laws of Maryland* Chapter 215, county health departments are required to issue a mobile reciprocity license to a certain mobile food service facilities and are authorized to charge a fee for a mobile food service reciprocity license;

WHEREAS, the Health Officer has recommended that the fee for a mobile food service reciprocity license be set at Three Hundred Dollars (\$300.00) per license issued or renewed and that the County adopt the regulations promulgated by the Maryland Department of Health and Mental Hygiene pertaining to the mobile food service reciprocity license, as amended from time to time, following public hearing;

WHEREAS, notice of a public hearing was published in The Recorder, a newspaper of general circulation in Calvert County on May 5, 2017 and May 12, 2017, and the Board of County Commissioners did conduct this public hearings as advertised to allow public comment on this proposal; and

WHEREAS, upon consideration of the comments that had been presented at the public hearing, and the staff recommendation, the Board of County Commissioners, sitting as the Board of Health for Calvert County, has determined that adoption of regulations promulgated by the Maryland Department of Health and Mental Hygiene pertaining to the mobile food service reciprocity license, as amended from time to time, and setting the mobile food service reciprocity license fee in the amount of Three Hundred Dollars (\$300.00) is in the best interests of the health, safety and welfare of the citizens of Calvert County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Calvert County, Maryland, sitting as the Board of Health for Calvert County, that Calvert County hereby does adopt and enact as local rules and regulations those regulations promulgated by the Maryland Department of Health and Mental Hygiene, as amended from time to time, pertaining to mobile food service reciprocity license and does hereby set the mobile food service reciprocity license fee and charge in the amount of Three Hundred Dollars (\$300.00);

BE IT FURTHER RESOLVED that the foregoing recitals are adopted as if fully rewritten herein; and


