ⁱⁱⁱ **REDESIGN:** All Revised Plans, rebuttals, revised calculations and other documents to be considered by the Planning Commission or staff **MUST be submitted by Revisions/Argument Submitted**

^{iv} **Revisions:** Revision Date to be considered at the PC meeting date consistent with that line on the schedule. Late submittals will be scheduled with the corresponding PC meeting.

^{vi} **CONCEPT REVIEWS:** Concept Reviews are submitted at the SEG meeting. Comments shall be provided verbally at the meeting to the applicant. In accordance with 7-1.07.A.4 of the Zoning Ordinance, written comments will be submitted to the applicant within 15 working days of the meeting.
