

**PERTAINING TO THE CHANGE OF DEPARTMENT NAME FROM
CALVERT COUNTY DEPARTMENT OF PLANNING & ZONING
TO
CALVERT COUNTY DEPARTMENT OF COMMUNITY PLANNING & BUILDING
(Text Amendment Case No. 12-05)**

WHEREAS, *Article 66B* of the Maryland Annotated Code, as amended, empowers the Board of County Commissioners of Calvert County, Maryland to enact Zoning, Subdivision Ordinance and other land use controls to promote the health, safety and welfare of the citizens of Calvert County, and to provide for its administration, enforcement and amendment; and

WHEREAS, pursuant to that authority, the Board of County Commissioners of Calvert County, Maryland has heretofore adopted the Calvert County Zoning Ordinance administered heretofore by the Calvert County Department of Planning & Zoning; and

WHEREAS, after study and evaluation, the Department of Planning and Zoning of Calvert County recommended to the Board of County Commissioners that the Department name be changed from Planning & Zoning to the Calvert County Department of Community Planning & Building; and

WHEREAS, after due notice was published, the Board of County Commissioners of Calvert County, Maryland conducted a public hearing on May 1, 2012, at which time the proposed Department name change was discussed, staff's recommendations were considered, and public comment was solicited; and

WHEREAS, after considering the evidence which had been presented at the public hearing regarding the proposed Department name change, the Board of County Commissioners of Calvert County, Maryland determined it is in the best interest of the citizens of the County to change the name of the Department.

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, that, upon the Effective Date of this Ordinance, the official name of the Calvert County Department of Planning & Zoning shall be changed to the Calvert County Department of Community Planning & Building; and

BE IT FURTHER RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, Maryland that, upon the Effective Date of this Ordinance, all references to the Department of Planning and Zoning , wherever they may be found, shall be deemed to refer instead to the Calvert County Department of Community Planning & Building; and

BE IT FURTHER RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Ordinance or the Calvert County Zoning Ordinance, is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Ordinance shall be enforceable and valid; and

BE IT FURTHER RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and

BE IT FURTHER RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, Maryland that this Department name change shall be effective July 1, 2012 (the "Effective Date").






