- **Completed applications MUST be signed and notarized.**
- **Documentation of your experience must be submitted on official company letterhead with your application, signed by the Master Electrician for whom you worked.**

Letters of verification from IBEW must indicate specific dates of employment and account of pertinent experience.

Minimum Qualifying Experience: (Please select one)

- Master Electrician:** Must verify continuous engagement as their primary occupation during the three (3) years immediately preceding the date of their application as a Journeyman or seven (7) years total in the electrical trade under the supervision of a Master Electrician.
- Restricted (limited) Electrician:** Must verify four (4) years as an Apprentice and three (3) years as a Journeyman working under a Master Electrician.*
- Low Voltage:** Must verify four (4) years of experience in the electrical trade under the supervision of a Master Electrician
- Journeyman Electrician:** Must verify four (4) years of experience in the electrical trade under the supervision of a Master Electrician.

All fees must be remitted in full upon application submittal. Fees are non-refundable, and non-transferable.
