

**FOR THE PURPOSE OF SETTING AND ESTABLISHING AN
ALTERNATIVE SPEED LIMIT ON OLD BAYSIDE ROAD IN THE
HALF MILE RADIUS OF BEACH ELEMENTARY**

WHEREAS, pursuant to the authority granted by Section 21-803 of the Maryland Annotated Code, Transportation Article, the Board of County Commissioners of Calvert County, Maryland may alter the speed upon certain public roads;

WHEREAS, the Director of the Calvert County Department of Public Works has advised that the maximum speed limit set forth in Section 21-801.1 of the Maryland Annotated Code for that one-half (1/2) mile on each side of Beach Elementary School on Old Bayside Road, is greater than reasonable or safe under existing conditions of road design, motor vehicle traffic and pedestrian safety;

WHEREAS, the Director of the Calvert County Department of Public Works has advised that 20 miles per hour is a reasonable and safe maximum speed for that one-half (1/2) mile on each side of Beach Elementary School on Old Bayside Road.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Calvert County, Maryland finds the maximum speed limit set forth for that one-half (1/2) mile on each side of Beach Elementary School on Old Bayside Road is greater than reasonable or safe, and that one-half (1/2) mile on each side of Beach Elementary School on Old Bayside Road be set and posted at 20 miles per hour pursuant to the recommendation of the Calvert County Department of Public Works.

BE IT FURTHER RESOLVED that the Director of the Department of Public Works is directed to install the signage necessary to implement this Resolution in accordance with Section 21-803(c) of the Maryland Annotated Code, Transportation Article;

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland, that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, by a court of competent jurisdiction, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid, unless deletion of the invalid portion would defeat the clear purpose of the Resolution, or unless deletion of the valid portion would produce a result inconsistent with the purpose and intent of the Board of County Commissioners in enacting this Resolution;

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation and publication of a fair summary.
